 - a) Eight (8) copies of the Synopsis containing the title of the proposed research work, its objective, the importance of the investigation, the details of the procedure and the review of the earlier work done in the area of the proposed research work, not exceeding in 1000(One Thousand) words.
 - b) Attested copies of the following:
 - (i) Original Certificate & marklists of P.G. Degree.
 - (ii) Certificates in proof for previous research experience, if any.
 - (iii) Certificates in proof for relaxation in minimum marks prescribed for Ph.D. admission, as per Notification.
 - (iv) Certificates in proof for exemption from Entrance Test as per Notification
 - c) No Objection Certificate in original from the employer in the case of employed persons.
 - d) Original Chalan receipts for Rs.500/- (Rupees Five Hundred only) and Rs.50/- (Rupees fifty only) towards Application Fee and Cost of Application Form respectively.
