## **ORDER**

- 1. University orders were issued vide paper read (1) above, appointing Dr. Abdul Majeed K C, Associate Professor, Dept. of Library and Information Science, Kannur University, Thavakkara Campus as the Head of the Research Centre at the Dr. Hermann Gundert Library, Kannur University, on an additional charge basis.
- 2. Dr. Abdul Majeed K C, Associate Professor, Dept. of Library and Information Science, Kannur University, Thavakkara Campus has requested, vide paper read (2) to be relieved of his duties as the Head of the Research Centre, Dr. Hermann Gundert Library, Kannur University since he has completed 60 years of age on 21.10.2024 and is now in the period of superannuation.
- 3. The Vice Chancellor has entrusted the Registrar, vide paper read (3), with appointing a suitable person as the Head of the Research Centre at the Dr. Herman Gundert Central Library.
- 4. The Registrar has nominated Dr. Priya T K, Deputy Librarian at the Dr. HGCL as the Head of the Research Centre, Dr. Herman Gundert Central Library, Kannur University as per the orders cited as paper read (4) and the Vice Chancellor has endorsed the appointment of Dr. Priya T K vide paper read (5).
- 5. In consideration of the above, the following orders are, therefore issued:
- i. Dr. Priya T K, Deputy Librarian, Dr. HGCL is appointed as the Head of the Research Centre, Dr. Herman Gundert Central Library, Kannur University, Thavakkara Campus on an additional charge basis relieving Dr. Abdul Majeed K C of his duties.

access E-reference materials needed for the research scholars.

All the administrative requirements of teacher fellows attached to the Central Library including issuance of Duty Certificates, Attendance Certificates, forwarding Bills and vouchers connected with UGC and other funding agencies, contingency grants and other related works will be catered to by the Head of the research centre.
- vi. The Head of the research centre will monitor and coordinate the course work in subjects attached with the Herman Gundert Central Library.
- vii. The Head of the Research Centre will draw advances from the University funds earmarked for the Head of the Research Centre, Dr. H.G.Central Library and ensure timely settlement of these advances.
- viii. The Head of the research centre will attend the centre, Dr.H.G.C.L, once a week without disrupting the routine work of the Department of the University to which she is attached.
