Kannur University - Ph.D. Programme - University Junior Research Fellowship (UJRF) for the current financial year (2025-26) to Full-time Research Scholars - Sanctioned - Distribution Orders issued.

ORDER

- 1. As per the Guidelines for University Junior Research Fellowship, "The candidates who have already registered for Ph.D. programme in any of the University Departments or University recognized research centres under Kannur University and who are qualified in the test conducted by the University for the purpose shall be eligible for the award of Junior Research Fellowship, subject to the conditions as may be determined by the Syndicate".
- 2. As per the paper read (1), Syndicate of the University has recommended that the Research Fellowship of the University JRF will be entitled to all Full Time Scholars, provided that they are not receiving any financial aid from any other agency.
- 3. University Junior Research Fellowship scholars, who have completed coursework were permitted to attend the concerned research centres from the very next day of completion of coursework vide paper read (2) and thus from 2014-15 coursework batch onwards, there is no gap of time period for the scholars between the completion of coursework and the date of joining at the research centre.
- 4. The tenure of the fellowship is three years including six-moth coursework programme and it commences from the date of joining the research centre or coursework centre, as the case may be, based on the registration orders of the candidate.
- 5. 76 Full time research scholars had been awarded University Junior Research Fellowship @ Rs.5000/- (Rupees Five thousand only) per month up to 31-03-2017 and @ Rs.10,000/- (Rupees Ten thousand only) per month w.e.f. 01.04.2017 for a period of 3 years vide paper read (3).
- 6. Out of the above 76 research scholars availing Junior Research Fellowship, the undermentioned 41 research scholars are now become ineligible for the award of Junior Research Fellowship (as the tenure expired / converted to part time / selected by other funding agencies / discontinued / submitted the final thesis/ completion period expired/ cancellation of Registration) and they have been excluded from the list of awardees as per the orders of the Vice-Chancellor.

In response to the Notification read (4) above, out of the 50 applications received, 48 (Forty Eight) Full-time Research Scholars are found eligible to consider for University Junior Research Fellowship for a duration of three years. Sughisha P, Research Scholar in Sanskrit has been included in the list upon her request, considering that the candidate has not availed full eligible amount sanctioned to her vide U.O. No. RD/C3/49/2022 dated 15.03.2022. Including her, a total of 84 (Eighty Four) full-time research scholars are eligible for the Junior Research Fellowship, as detailed below:

- 8. As per Kannur University detailed budget estimates for 2025-26, an amount of Rs.1,50,00,000/-(One crore and fifty lakh only) is allotted to research fellowship under the head of account Part II Plan MH-28-428-276.
- 9. The Clause v at para 10 of the U.O. No. RD/C3/5817/2023 dated 20.03.2024 (vide paper read as 3) was modified vide paper (5) as follows implementing the resolution no. 2025.319 of the Syndicate meeting held on 05.05.2025:

"Each Fellow shall be Full-time research worker while holding the fellowship and shall not accept any other remunerative work. If a scholar takes up an assignment in between the tenure, they shall not be eligible to draw the fellowship for that period and under any circumstances, the tenure of the fellowship will not be extended beyond 3 years. A certificate from the Research supervisor, countersigned by the Head of the Research Centre, to the effect that the research scholar is not availing any other financial assistance, shall be submitted, each time when the candidate applies for University Fellowship."

10. Considering the matter in detail, the Vice Chancellor has accorded sanction to award University JRF to 49 (forty nine) number of ongoing / newly registered full time research scholars in addition to the 35 (thirty Five) numbers of full-time research scholars who were awarded University JRF vide paper read (3) at a rate of Rs.10,000/- (Rupees Ten Thousand only) per month.

11. The following orders are, therefore, issued on the matter:

- i) The University Junior Research Fellowship in respect of 41 research scholars who are ineligible due to various reasons as mentioned at para (5) is cancelled.
- ii) University Junior Research Fellowship to 84 research scholars listed at para 6 is sanctioned. The tenure of University Junior Research Fellowship is three years and the amount per month is @ Rs.5000/- (Rupees Five Thousand only) up to 31 st March 2017 and @ Rs.10,000/- (Rupees Ten Thousand only) w.e.f. 1 st April 2017. For those scholars who

have done the coursework and a break occurred before joining the research centre, the first tenure of the fellowship will be released from the date of joining to course work based on the certificate issued by the course work coordinator and the remaining tenure of the fellowship will be reckoned from the date of joining at the research centre after the completion of course work.

- iii) The fellowship will be awarded subject to the availability of funds at the University.
- iv) The scholar should furnish their employment status once in six months.
- v) Each Fellow shall be Full-time research worker while holding the fellowship and shall not accept any other remunerative work. If a scholar takes up an assignment in between the tenure, they shall not be eligible to draw the fellowship for that period and under any circumstances, the tenure of the fellowship will not be extended beyond 3 years. A certificate from the Research supervisor, countersigned by the Head of the Research Centre, to the effect that the research scholar is not availing any other financial assistance, shall be submitted, each time when the candidate applies for University Fellowship.
- vi) Only Full-Time Research Scholars and whose research works are regularly monitored by Research Guide concerned are eligible for University JRF. In case of Research Guides who are not available for regular monitoring of research work of a Research Fellow, the Head of the Research Centre will intimate the status for taking a decision in the award of JRF. Further, the decision of the University in this regard will be final.
- vii) The Progress Report of Research work, Attendance Certificate, stamped receipt, prior permission letter from the Guide and Head of the Research Centre for availing duty leave, a copy of the University order granting registration and University order sanctioning the fellowship shall be enclosed each time with the bill claiming University JRF.
- viii) The Research Fellows are entitled for a maximum period of 15 (fifteen) days Casual leave in a calendar year, in addition to Public Holidays, 30 days of duty leave per year and 6 months of special duty leave for the completion of field work / field reference / lab work during the entire research period, with fellowship. Women candidates are eligible for maternity leave as per rules once during the tenure of the award.
- ix) The research fellows who are availing leave for data collection and other outstation research activities shall obtain prior permission from the Head of Research Centre through the Research supervisor. An attested copy of the request approved by the Research Guide, shall be forwarded to the University by the Head of the Research Centre, along with the application / bill for Junior Research Fellowship.
- x) The fellowship now ordered shall be terminated at any time during the tenure and the decision of the University will be final and binding in this regard.
- xi) The fellowship granted shall be cancelled, on misconduct of the Research fellow, unsatisfactory progress report of Research, lack of regular supervision of research work by Research Guide concerned and ineligibility of the research fellow for the award of JRF, if found later.
- xii) Full Time scholars who availed University Fellowship and failed to submit the final thesis before the due date as per registration, will have to refund the entire

fellowship amount. An affidavit on stamp paper worth Rs.100/- (Rupees One hundred only) duly countersigned by the Research Supervisor should be submitted along with the first bill to this effect.

- xiii) Full-time scholars who are eligible to avail the fellowship have to submit the bill with supporting documents claiming the Fellowship for every completed six months, failing which the fellowship granted is liable to be cancelled.
- xiv) Bill claiming University JRF should be submitted strictly adhering to the direction contained in the Notification read (4). Bills submitted in violation of the same will not be entertained and will be rejected without further reason.
- xv) The expenditure towards the award of Fellowship will be met from the Head of Account Part II Plan MH-28-428-276 Research Fellowship of the current year's budget estimates.
 - xvi) The University Order read (3) above stands modified to this extent.
