ORDER

- 1. Syndicate, vide paper read (1), has approved the proposal from the Pro Vice Chancellor for granting advance scholarship of ₹ 5,000/- per mensem to the five Research Students from Manipur till they receive any other scholarship.
- 2. Research and Development Cell, as per paper read (2), was entrusted to implement the syndicate resolution.
- 3. Vice-Chancellor, vide paper read (3) has ordered to sanction the advance scholarship initially for a period of 6 (Six) months, which may be extended, if necessary.
- 4. Finance branch, vide paper read (4), has endorsed to sanction the advance scholarship from the Head of the account "MH-29-329-264" Research Scholarships & Fellowships other than UGC of Part I Non Plan, Budget Estimate 2023-24.
- 5. Having examined the matter in detail, following orders are issued as approved by the Vice Chancellor.
 - i. The following four students from the state of Manipur are sanctioned with an advance scholarship of ₹ 5,000/- (Rupees Five thousand only) per mensem for six months from the date of their registration.

- ii. The candidates shall submit the following documents for receiving the advance scholarship.
 - a. Application in prescribed format duly forwarded by the Research Supervisor and Head of the Research Centre.
 - b. Copy of the University Order sanctioning the advance scholarship.
 - c. Self attested copy of the bank passbook front page & Stamped receipt
 - d. Undertaking of repayment/settlement of advance in the format prescribed and

duly forwarded by the Research Supervisor and Head of the Research Centre.

- iii. The students who have been awarded with UGC NET JRF or similar fellowships/scholarships by Central/State level funding agencies via DBT shall repay the entire advance drawn within three months from the date of receipt of their first month's fellowship. For those scholars who is sanctioned with University JRF, the advance drawn shall be adjusted from the first bill submitted for claiming the University JRF.
- iv. The expenditure towards the above shall be met from the head of the account MH-29-329-264 Research Scholarships & Fellowships other than UGC of Part I Non Plan of the current year's budget estimates.
