ORDER

- 1. University Orders were issued vide paper read (1), fixing the fees for the first, second and third extensions of the research period for submitting the Ph.D. final thesis after the maximum period stipulated by the Ph.D. regulations has expired.
- 2. Various fees related to the Ph.D. programme were increased with effect from 08.08.2024, vide the University Orders cited as paper read (2), based on the government policy that allows for a 5% annual increase in fees. However, the fees for the second and third extensions of the research period were not included in this general fee enhancement order (The fee for the first extension was included in the general U.O. and was increased accordingly).
- 3. The Monitoring committee on Research has approved the draft proposal for fee enhancement for extensions vide paper read (3).
- 4. Considering the matter in detail, the Vice Chancellor has ordered to place the proposal before the Syndicate for approval.
- 5. Consequently, the Syndicate of the University, in its meeting held on 30.12.2024 considered the draft proposal regarding the enhancement of fee for extensions of the research period and approved it vide paper read (4).
- 6. The resolution of the syndicate has been implemented, and the details of the fees for the first, second and third extensions of the research period for submitting the Ph.D. final thesis, after the maximum period stipulated by the Ph.D. regulations has expired, are as follows:

SI. No.	Period of Extension	Fine/Fee in Rupees	Sanctioning Authority
1	One Year (1 st Extension)	₹ 6,070/-	Vice Chancellor
2	6 Months (2 nd Extension)	₹ 16,500/-	Syndicate
3	6 Months (3 rd Extension)	₹ 16,500/-	Syndicate

7. The revised fee structure will come into force with immediate effect and fees once paid will not

be refunded.

- 8. Research scholars who have outstanding fees are required to make payments according to the revised fee structure.
- 9. The U.O read as paper (1) above stands modified to the above extent.
- 10. Orders are issued accordingly.
